

Minutes of IADVL - EC meet held at Lucknow

on 30th & 31stMarch 2013

The Executive committee meeting of IADVL for the year 2013 was held at hotel Gemini Continental, Hazratgung, Lucknow. It was attended by following members:

EC members: Dr. Suresh Talwar, Dr. C.R Srinivas, Dr. Deepak Parikh, Dr. P. Narasimha Rao, Dr. DBN Murthy, Dr. Kiran Godse, Dr. US Agarwal, Dr. KS Ram, Dr. Kanthraj

Invited members: Dr. DM Thappa, Dr. ShyamVerma, Dr. ShyamantaBarua, Dr. Suresh Joshipura, Dr. V.K Sharma, Dr Rajeev Sharma, Dr. Amar KanthJha, Dr. Ramesh Bhat, Dr.Jayadev Betkerur, Dr. AmitValia, Dr. Sacchidanand and Dr. Devesh Mishra

Did not attend: Dr. Arijit Coondoo and Dr Arun Inamadar

Dr Suresh Talwar, president, IADVL invited all the members to the meeting. The meeting was started with the release of hard draft copy of electronic IADVL news bulletin of April 2013. On enquiry from Dr Ramesh Bhat, Dr Rao thanked Dr Ramesh and informed the house that this being draft copy, the election notification and oration announcements would be included before uploading to the final e version to the website. He also informed the house that information regarding announcement of national elections would be communicated to members through bulk SMS and e-group mailers.

Information given to House by Secretary IADVL:

IADVL – GSK Quiz for post graduate students: GSK has agreed to renew the contract for next three years.

IADVL Systopic oration issue: Sponsorship lapses by 2014. Systopic laboratories have agreed to renew their oration sponsorship for next 5 years.

IADVL-Neutrogena oration: Sponsorship lapses by 2014. (Last oration with this name at DERMACON- New Delhi): Neutrogena expressed its disinterest to renew the sponsorship. *We need to find new sponsors.*

Sponsorship of IDOJ: Galderma's Sponsorship of IDOJ has expired in March 2013. Ranbaxy has agreed to enter in to 3 years contract for sponsoring this e-journal of IADVL.

Agenda discussed at the EC meet:

1. <u>Proposed by Dr Suresh Talwar DERMACON :</u>

A. **If any Route changes to reach Venue:** In case of certain unforeseen events (like CYCLOTHON at Ahmadabad) the organizers should inform the people in the auditorium by putting up such messages and making announcements.

Result: EC Accepted that any changes, alterations or reschedule in programs in DERMACON have to be informed to delegates in advance and by proper announcements.



B. **Separate registration and food counters for Senior Citizens (70 year above) :**The registration form should have a separate column for Senior citizens (above 70) and physically handicapped .A separate badge highlighting their senior citizens status , separate registration and food counters be provided .This should be a part of DERMACON SOP

Result: EC accepted it. A separate registration & food counter to be provided for senior citizen members of IADVL.

C. **Status of Abstract:** When somebody submits **abstract** & if it was found to be not up to the mark, it is for the organizers concerned to **inform by mail** accordingly.

Result: EC accepted it. The DERMACON scientific committee is requested that: all abstracts have to be acknowledged and status has to be informed promptly. The not-up-to-the-mark abstracts have to be encouraged for e-poster. Rejection has to be informed to the sender.

2. <u>Proposal sent by Dr Arijit Coondoo:-</u> (Member not present) SOPS finalized till date should be put on web and be published as annexure to the constitution booklet.

New SOPS being prepared and planned: SOP for Branches, Vice Presidents, Joint Secretaries, Standing Committees, resignation of office bearers, bidding and other aspects of international conferences, SIGs (though it is included in SOP for Academy we can always remove it from there and prepare a new SOP), interaction with Sister societies, CUTICONs, DERMAZONEs, Quiz program. Preparation of history book of IADVL

Discussion: EC and invited members discussed the way to go about them. It was decided that all SOPs have to be in the web. To be discuss each of them in the E-groups of CC if possible and later at CC meet.

3. Proposed by Dr. Jayadev Betkerur:- Proposed to discuss issues of SARCD 2015 - Registration fees, Formation of organising committee, Dates and Venue.

Discussion: Dr Jayadev informed that new conference hall is being constructed in JSS medical college which would be suitable for conference. He suggested to inform the dates. Aug 28-30 or Sep 4-6 of 2015.Regarding the proposal of Dr Jayadev about honoring of SARAD President and Sect. General during DERMACON and invitation to be sent for DERMACON.

Discussion: Dr Rao mentioned that SARAD is a separate organization with its owns structure and finances. Dr Joshipura however, informed the house that DERMACON organizers of Ahmedabad had sent invitation to all SARAD executives and some of them attended DERMACON. Dr Talwar and Dr Narasimha Rao informed the house IADVL EC did not get any official invitation from organizers of SARAD conference of Colombo till now. Dr Rao also informed the house that the SARAD organizers are not responding to mails sent to them. Dr Jayadev informed the house that he would



take up the matter with the organizers of SARAD. The matter of honoring president and secretary of SARAD during DERMACON was not considered by the house.

Dr Jayadev proposed to have the conference event as 1 day CME + one and a half a day conference during SARAD. He mentioned that he would discuss this matter with EC of SAARD during meet at Colombo. Members suggested separate delegate fees for Indian delegates. The proposal of merging of SARAD meeting at Mysore and DERMAZONE was not passed.

Proposed by Dr. C.R Srinivas:-

A. FINANCIAL ACCOUNTS

(a) The host branch is responsible for all financial matters related to the DERMACON. The IADVL will bear no financial liability of the DERMACON.

(b) The host state branch should have a Permanent Account No. for income tax. The DERMACON should also have a separate PAN as they will have to pay the income tax and then hand over the savings to the Honorary Treasurer, after the conference.

(c) It is expected that a minimum 20 % of the total conference collection will be given as savings to IADVL

(d) An audited income and expenditure account of the conference shall be submitted by the Organizing Committee to the Honorary Treasurer within 6 months. The detailed bank accounts, transactions, and quotations received from event management companies should be submitted to impart transparency to the financial aspects of the DERMACON. It will be submitted for auditing by the IADVL.

Discussion and Result: Accepted by the EC in principle but modalities to be worked out. Dr VK Sharma suggested that a MOU must be signed between the conference organizers and national IADVL Dr Sacchi suggested that in addition even the percentage of total money collected must be earmarked to the national IADVL. Total collection should exclude money to be paid toward service tax and IT. The house agreed that the signatories of the MOU would be responsible for the correctness and submission of the accounts to IADVL. There has been suggestion that 15% of MIDDERMACON collection should be earmarked to national IADVL. Dr Jha agreed to this suggestion in principle.

Action to be taken in case of default the following action will be initiated at 15 days interval. The Honorary Secretary will write to Organizing Chairpersons reminding them to submit the account. If account is not submitted within 15 days a second reminder will be sent permitting another 15 days time. If still account is not submitted a final reminder will be sent. If still the accounts are not submitted then names of all the members of the local organizing committee will be deleted from all the E group. If still accounts are not submitted the local organizing team will not receive the hard copy of IJDVL. If still the accounts are not submitted the similar action in a time bound manner will be taken against EC of the state which has organized the DERMACON.

First Reminder after due date ----→Second Reminder---→ 3^{rd} and Final Reminder ---→ Delete E Facilities ---→ Stop Journal --→ Not eligible to contest --→ Action against state EC



Line of action applies to organizing Sec., treasurer and president of the DERMACON: National Auditor Will Be Send To Audit The Account If No A/C Received In 9 Months.

Discussion and Result: Dr Deepak Parikh suggested that the balance sheet of DERMACON 2012and audited account to be presented in CC meeting at Patna. This would enable us to discuss the last balance sheet and also look for scope for improvement. It was also suggested that MIDDERMACON expenses should be submitted during subsequent DERMACON. This suggestion was accepted by the EC.

Proposal from Dr DM Thappa, Editor of IJDVL: Present position of IJDVL Deposits with IADVL. There need to be clarity on the accounts and IJDVL accounts need to reflect separately. Dr RoopakSaxena, the outgoing treasurer in March 2010 has mentioned the IJDVL finances in the IADVL accounts as follows:

Every year bifurcation of IADVL & IJDVL accounts and ratified in AGM. Presented by Roopaksaxena – 31 march 2010.

Jaidevand Ramesh Bhat in their tenure from 2010-2012 have to update these accounts based on the information they have. (Dermacon –lucknow and gurgaon surplus -47,80000/ (20 %), plus membership fees -2000000/ @ 1250/ per member, plus add Dermacon surplus –Jaipur -400000. Dr Thappa pointed out that despite his repeated request the accounts of IJDVL are not being shown separately by IADVL executives.

Discussion: There was a long discussion on this matter. The house felt that there is definitely a need to keep and shoe the finances of IJDVL separately with in IADVL accounts, which was not done during year 2012-2012. Dr Ramesh Bhat and Dr Jayadev were asked to look into matter in consultation with their auditor and present exact figures of finances of IJDVL at the end of their tenure as certified by their auditor in proper format. Dr Ramesh Bhat and Dr Jayadev agreed to the suggestion of the house and assured the house that they would consult their auditor at Mysore to arrive at correct financial accounts/ balance of IJDVL by the end of their term and pass on the same to the present EC for continuation of the accounts. Dr Thappa was assured that IJDVL account would be finalized in next few months.

The house accepted the proposal by Dr Suresh Talwar and Dr Deepak Parikh that the President-Elect should be part of finance committee.



4. Proposed by Dr. K. H. Basavaraj:-

There should be separate e- link for public in IADVL website. Dr Kanthraj made a presentation.

Discussion: The house lauded the initiative and suggested that a hort \mathcal{E} concise articles with photographs, most frequently asked questions written in a very simple language should be included. SIG's to be involved along with the Academy in the peer review of the content to be uploaded.

5. Proposed by Dr. Deepak Parikh and Dr Arijit Coondoo:-

One man, one post proposed that those who ALREADY are part of the central IADVL Committees or are office bearers, should desist from taking part in academic activities of IADVL It is proposed that in IADVL matters one member should, unless under exigent circumstances hold one post.

They can be in SIG; however they should not apply for oration.

The following are the definitions of member and post. **Member:** A member is a person who is a Life member of IADVL with full voting rights and with no financial liabilities towards IADVL in any form. **Post:** Any post mentioned in the Constitution of IADVL. The tenure of a post begins from the day the member takes charge of that post (not from the day of filing nomination for election) and ends on the day his/her successor takes charge of the post

This includes: All elected posts (members of the IADVL National Executive Committee), Chairpersons and Conveners of standing committees of IADVL, Editors of IJDVL, IDOJ and textbooks of IADVL, and Atlas. Text book editors will be allowed to hold any post after the book is published. Organizing Chairperson, Organizing Secretary and Chairperson Scientific Committee of DERMACON, MIDERMACON and international conferences hosted by IADVL (during the 12 months prior to the Conference and till final accounts of the conference are audited and accepted by the respective General Bodies). Members of the Central Scientific Committee for DERMACON and MIDERMACON (except ex-officio members)

All elected office bearers of state branches. *This clause applies for president & secretaries only. DVL trust members it will not apply. They are exempted.*

Exclusions: The word "post" does not include: Members of any of the standing bodies of IADVL, Executive Committee members of state branches, Editorial Board and editorial advisory board members of the journals mentioned above, Permanent invitees to the Central Council, Judges of awards, Members of various committees of the conferences mentioned above and Faculty of any of the conferences mentioned above.



Exception: A chairperson or convener of a standing committee of IADVL National body or an elected member of the state executive can be a member of another standing committee Exigent circumstances: If the President feels that in the interest of the association this rule should be overlooked in selective instance, it should be done with approval of the EC and then ratified by Central Council.

Rider: The period of tenure of office bearers of different branches varies from branch to branch and may not be the same as of the national body; hence there may some unavoidable overlap between the time of completion of previous job and taking charge of the present job. However this overlap should be as short as possible, preferably not more than two months.

Discussion and result: The house could not discuss all aspects of this proposal in detail, hence it was decided to take it up in this issue separately. It was decided that Matter be referred to constitution committee.

6. Proposal by Dr. Kiran Godse:-

Subscription to Willey journal stopped due to the expenses involved, which was about 9 lakhs per year. The alternative was explored by Dr Kiran Godse and found 'Knowledge Genie' of abbot labs as a good alternative to get access to many good journals.

Discussion and result: The house approved it. But expressed that the decision would be reviewed during CC meet at New Delhi in Dec 2013 based on the progress. Accepted. To include reviewers of both IJDVL & IDOJ in subscribers for Knowledge Genie.

7. **Proposal by Dr. Deepak Parikh**:- SIG Coordinator need not be Central Council member.

Result: Accepted by the house

Tenure of all SIG coordinator should be for two years. (At present it is for 3 years) *Result: Not passed*

(Dr Arun Inamadar's proposal not taken up as wished to withdraw it)

8. Proposed by Dr. Arijit Coondoo:-(Member not present)

Updating We can also think on timelines for the annual updating of the Constitution so that it becomes a smooth affair, with the updated version being eventually uploaded on our website, e.g. minutes of the closing year's GBM should, after the EC's approval, be submitted by the Hon Gen Secretary within one month of DERMACON, the changes incorporated by the Chairperson and Convener within 1 month, approved by the entire committee in another month, sent to the EC for approval 2 weeks before the EC meeting.

9. Proposed by Dr. Suresh Joshipura:-

- 1. Road map for updating constitution
- 2. SOP for the constitution committee , final workup for CC meet at Patna



3. Any other queries by EC

Discussion: The road map suggested by Dr Joshipura was agreed by the EC in principle. Dr CR Srinivas suggested that as so many changes are being suggested to constitution, it is better it keep it as soft copy for time being, as it is easy to update it. The house also agreed to keep IADVL constitution and SOPs separate.

10. Discussion on AWARDS:

a) Appreciation awards: Dr Suresh Talwar EC should be empowered to issue 5 appreciation awards to the members who have rendered exceptional services for the betterment of IADVL . Members of various committees will also be eligible for this. However EC members will not be eligible

Decision of the EC: Up to 5 such awards to be given in the MID-DERMACON/IADVL day

b). **"Life time achievement award**" to 3-4 respected seniors. **Proposal by Dr Deepak Parikh:** There are many stalwarts who have excelled as dermatologists and richly deserve recognition. However, currently there is one award only and hence many respected seniors may not get recognition in their lifetime.

Decision of the EC: Two life time achievement Award to be given in the DERMACON. Modalities to be worked out.

Proposal: Initiation of IADVL -Kiwi Poster award: Dr Suresh Talwar inform the house that Kiwi pharmaceutical has approached him with a sponsorship money of 3 lakhs for institution of new poster award to be given during DERMACON.

Decision: Accepted, as there is only one award for posters at DERMACON till now. To be given to the best poster in the DERMACON. Category to be decided. The matter to be sent to IADVL awards committee and to be implemented from this year itself as sponsor is ready to enter in to agreement immediately.

11. The relationship between Sister Society and IADVL should be a win relationship. <u>A proposal by Dr. C.R.Srinivas</u>

The IADVL will extend the following facilities to Sister Societies

1) Organize focused session before the main conference in Consultation with Scientific Committee.

2) Plan the session during DERMACON along with SIG.

3) Will be provided time slot to conduct business meetings on request.

4) Will be provided space in the Exhibition hall to interact with members, recruit new members or showcase the achievements and collect registration fees for their conference and workshop.

5) Circulate announcements in IJDVL and IDOJ free of cost.

6) IADVL will undertake not to organize independent annual meeting related to Subspecialty .



The following are the reciprocal gestures requested from Sister Society.

1)The sister Society will also involve the SIG during the organization of the annual meet.

2)The Sister Society will also include the President of IADVL and his representative during the inaugural function.

3)The Sister Society will forward 15 % of the net amount collected during Annual Conference to IADVL

In case the Sister Society is unwilling to commit such an agreement, all the above mentioned facilities will be withdrawn and bidding will be opened for Annual meeting in the sub specialty to be organized by SIG under the banner of IADVL

Discussion: The president, IADVL to call the meeting with the president & Secretaries of Sister societies during MIDDERMACON, Patna. This to invite suggestions for mutual working & reciprocal benefit. Dr. ShyamVerma opined that one day session prior to DERMACON, however Dr. Ramesh Bhatt opined the existing slot given to them during the DERMACON is sufficient. Dr. JaydevBetkerur, opined that there should be benefit for an IADVL member, similar to a sister society member, for registration in the sister society conferences & scientific events.

12. A) Bidding for WCD by IADVL: Status report by Dr. Sacchidand: A slide presentation done by Dr Sacchidanand regarding IADVL bidding for WCD in year 2019, with Bangalore as venue.

Decision: EC accepted it in principle. Dr VK Sharma pointed out that the exact conference venue for hosting WCD has not been mentioned in the presentation.

B) Progress on preparation of new edition of IADVL text book of Dermatology: Dr Sacchidanand, also presented the progress in compiling new edition of IADVL text book of Dermatology as chief editor this book.

Discussion and result: He informed the house it may not be ready by MIDDERMACON as 30% of all chapters are yet to be received by him. He assured that house that it would be ready by December, by the time of ICD-DERMACON.

13. Progress on MIDDERMACON presented by Dr AK Jha: Dr Jha presented the progress and planning of MIDDERMACON at Patna by a slide presentation.

Decision: EC Accepted the presentation, with the suggestion to cut down the expenses and have Maximum savings so that the target of earning for IADVL through MID- DERMACON is met comfortably. Dr Jha informed the house that his total proposed budget is about 40 lakhs. He promised to make necessary arrangements and take care of CC midderma meet hosting and the CC members who would be attending it during the MIDDERMACON.

There was a discussion on the discounted fee for the CC members for MIDDERMACON. The house after hearing the objection from Dr Rajeev Sharma referred the constitution and noted that



there is no mention of non collection of fee from CC members. Later the house, by rise of hands supported the proposal of Dr Suresh Talwar that a concessional registration would be offered to CC members at Rs 2000/ while it would be Rs 4000 for ordinary members. No free registration for CC members.

14. ICD - DERMACON, New Delhi 2013 - Progress presented by Dr VK Sharma.

Discussion: The house appreciated the progress. Dr Narasimha Rao suggested that the 32 post graduates who would be taking part in national IADVL quiz should be given benefit of early bird registration. IADVL agreed to pay on their behalf. Dr VK Sharma and Dr Rajeev Sharma accepted the proposal.

15. Therapeutic guidelines (TG) prepared by IADVL TG committee of 2012– Discussion on the method of their publication:

Discussion: The finalized TG are to be published as e-articles in IJDVL and subsequently published as booklet with pharma support if possible. The process is about to begin. The review process is expected to take a few months in IJDVL. Dr Shyam Verma, editor of IDOJ appealed to the house, as the IDOJ is the official organ of IADVL, that half of the guidelines be sent to IDOJ for peer reviewing and publishing. Dr Thapp, as editor of IJDVL informed the house that he has no objection to it. The EC accepted his request and agreed that half of the TG may be sent to IDOJ.

16. **Proposal: Vacancies and committees** –If a member of IADVL committee retires before completing his tenure and is replaced by another by the EC , the tenure of such nominated(Adhoc appointment) member be restricted to the original tenure of the committee member

Decision: Accepted by the EC

17. **Training fellowship** – Some institutes like AIIMS have placed a rider that training fellowship in their institute will be restricted to dermatologist passed from government medical colleges. Shall we accept this precondition?

Discussion and result: Dr VK Sharma explained that such preconditions do exist and it becomes difficult to accept dermatologists from Private medical colleges. As it is a policy decision of AIIMS, he has very little control over the decision. The house decided that such information that AIIMS fellowships are open only for Govt Medical college PGs may me put in the notification itself and continue AIIMS as a centre for IADVL fellowships.

18. **CC members attending and voting** –There should be a cap on CC members allowed to vote during CC meetings of IADVL. States having more than 5 CC members will be allowed to select 5 members to vote as and when the need for voting arises.



Result: This proposal was Rejected

19. **IADVL Scholarships eligibility to members- guidelines:** They should be given only once in life time of a member.

Discussion and Result: In principal we should not give overseas scholarship to same individual twice. To prevent such happenings, a clear instructions be given in the application and undertaking taken from the candidates applying for any IADVL overseas scholarship/fellowship. Applicants should clearly provide information about any past scholarships/fellowships received through IADVL. Any scholarship awarded through IADVL to an individual is once in a lifetime only. Archiving to be done and the list of recipients for various scholarships have to maintained strictly and displayed in the website.

20. **Proposal Guidelines Governing Interaction of IADVL Special Interest Groups With All Commercial Interests:** Dr Shyamanta Barua, Convener, IAD.

A. All financial dealings of a Special Interest Group (SIG) with a commercial interest (defined by the <u>ACCME Standards for Commercial Support</u> as any entity producing, marketing, re-selling, or distributing healthcare goods or services consumed by, or used on, patients) will be through the IADVL Academy of Dermatology (Academy) with the concurrence of the IADVL Executive Committee (EC).

B. A tripartite (SIG Coordinator, Academy Chairperson and the Pharmaceutical company involved) Memorandum of Understanding (MoU) will be submitted to the Honorary General Secretary of IADVL, who will thereafter release the fund as per the requisition by SIGs with time bound financial planning of expenditure.

C. All financial support for any activity should be in the form of unrestricted educational grants that can be acknowledged by writing: "Supported by an unrestricted educational grant from ...". It should be categorically mentioned in the MoU with the concerned pharmaceutical company that it cannot construe such sponsorship as an endorsement of any product or instrument or similar by IADVL. That the concerned pharmaceutical company can, under no circumstances, make use of the IADVL logo for any promotion, should find explicit mention in the MoU.

If a grant has to be accepted for scientific publications, it would be acknowledged with – "Publication has been made possible by an educational grant from" or "Print courtesy from educational grant of". Additionally, for any such published material, there should be a disclaimer – "The IADVL does not endorse or promote any commercial product" and all authors should declare any conflict of interest and mention sources of funding. *Decision: Passed by EC in principle*.



21. **SERVICE TAX:** The importance of clarifying service tax issue was discussed. Dr Rao informed the house that the auditors suggested that as it falls under the head of central excise, expert opinion need to be taken on its applicability to various aspects of IADVL activities. The expert legal opinion on this issue can incur an expenditure of about Rs. 1 lakh to IADVL.

Discussion and result: The service tax matter was discussed in detail. As each year IADVL has to pay a huge tax under this head, all the necessary opinions need to taken as needed. The permission to approach expert in this regard was granted by the EC.

It was also suggested that this MIDDERMACON at Patna be conducted under IADVL PAN (number). Pros and cons discussed. Discussion inconclusive.

22. **Proposed by Dr. G.R. Kanthraj:** Fixed cutoff date to elect cc members or completion of all cuticons & functioning of E-CC forum:

23. CUTICONs are being conducted independently by their respective states with various dates around a given year. Election of office bearers is conducted during those events. Some of the states would not have conducted their annual events and are unable to provide the current list of CC members and it can cause delay in the formation of IADVL_CC for that year.

Following measure can improve better function of IADVL_CC in future.

All cuticons should be completed or elect cc members by fix a cut off date

All state secretaries should send a complete list of those CC members with e-mail IDs to Hon. Gen .Sec. by <u>fix a cut off date</u>.

- Formation of IADVL_CC should be completed by fix a cut off date.
- Functioning of IADVL_CC should start by fix a cut off date.

It enables President & Hon. Gen. Sec. & their team to form & function IADVL_CC smoothly.

Discussion and result: Detailed proposal has to be sent to the constitution committee

Proposal from Dr KS Ram: Proposal to start a 'Media wing of IADVL': Proposed that IADVL should have a exclusive 'Media wing of IADVL' to facilitate dissemination of its views. This wing would interact with electronic and non electronic media from time to time and when necessary to make a impact of its views at regional and national level.

Discussion and result: Agreed in principle for need of such wing. Decided to take the idea forward by discussing it at EC and cc groups.

Secretary IADVL, Dr P Narasimha Rao with a brief vote of thanks to all members, concluded the EC meeting.

New proposal sent by members to be discussed at CC **MIDERMA** meet on Meet Patna on 17th & 18th August 2013:

1. Proposed by Dr. C.R Srinivas:-

Inauguration DERMACON and MIDERMACON Background The inauguration of DERMACON with elaborate seating arrangement, unwanted or less welcome chief guest is a waste of time and night mare for organizers. Anything that can go wrong will go wrong and our inauguration ceremony has so many intricacies as per our constitution and to add to this the organizers add something extra to further complicate criteria for being seated on the dais. The eligibility for a chair on the dais is far from satisfactory and has many stalwarts less happy. Lighting the lamp and the lamp not co operating offers needless entertainment to the audience. It is time to simplify the ceremony. I suggest the following protocol **Proposal** At the appointed time The President will go to podium and deliver a brief welcome address which is not more than 4 minutes. During this period he will welcome the audience and place on record his sincere thanks to local organizers. This will be followed by a short briefing by the Chairman Scientific on how to get the best out of the sessions. He will tell about the halls arrangement, its location, the arrangement for the posters, preview rooms etc. This brief ceremony will be followed by plenary session. A moment of silent prayer may be permitted

2. Proposed by Dr R G Torsekar, Seconded by Dr Vishalakshi Viswanath :-

Proposal-1.

- I. IADVL Digital Lecture Series- updation and availability to members by incorporating in the website: Proposed by Dr. RG Torsekar and seconded by Dr. Vishalakshi Viswanath: Digital Lecture Series are almost five years old now and needs updating, We propose that updation should be taken up at the earliest and it should be put on the web for usage of the members. New lectures (dermaotherapeutics) needs to be added; older lectures need to be updated, the format can be made more interactive; addition of MCQs and quiz is needed. A link with the Atlas can be provided; the images can be picked up from there for completion and adding variety to the lectures. It is also proposed that it should be made available to libraries of the Medical colleges so that both faculty and students can avail of the knowledge material.
- **II.** Facilities for physically handicapped at Dermacon and Middermacon: Proposed By Dr. RG Torsekar: The site Inspection committee for MID DERMACON AND DERMACON should see that proper special arrangements are present for the Physically challenged members for their movement at all arenas in the conference- registration, enquiry, dining areas and washroom/ toilet facility.
- III. Patient education material to be incorporated in IADVL website : Proposed By Dr. VishalakshiViswanath: IEC material for patients should be incorporated in our website; most of our sister societies have incorporated IEC material relevant to their subspecialties. A uniform format for various common diseases and procedures performed (needs to be brief and precise) should be formulated and incorporated in IADVL website. All members should be able to advise



the patients to connect at the site for information or even take prints to keep in their respective clinics.

IV. Compilation and e group activities of HOD of all medical Colleges: Proposed By Dr. Vishalakshi Viswanath: A compilation of HODs of various medical colleges all over India needs to be updated (the previous one probably done about 7 years ago) ; an e group can be created and this can look into various activities like PG/ UG curriculum; development and sharing of educational resource material; integrated teaching; representation to administrative authorities. This will be of help to SIG curriculum too.

Proposal -II The Patient Education Diary may not reach every member and additions to it is bit difficult so to make it available to others we can make a smart phone Application ,costing less than a lakh of Rupees, It will be easy to add newer conditions, and the pictures can be zoomed in for better explanation ability, can have link with clinical photographs atlas, so as to show more number of pictures for patients to identify and match their conditions. We can incorporate it in the website of IADVL too for free Download.

Proposal – III Proposed by Dr T D Rajan and seconded by me Proposal to provide a webpage to every member of IADVL, linked to the official website :Background: Internet is the medium of the future and everyone across the globe is expected to seek information and solutions to their healthcare needs through this powerful medium. A number of unscrupulous elements and commercial organisations are dominating this medium even though they lack the skill and qualification necessary to offer medical advice. IADVL is a major body with a membership of over 6000 across India. This constitutes a large chunk of the global dermatology workforce. In the face of competition from quacks and unethical practitioners, IADVL must ensure its presence in the minds of its citizen as an organisation of qualified and standardized specialists in the field of dermatology, venereology/sexology, cosmetology, trichology, onychology, dermatologic surgery etc. Many individual dermatologists have put up their websites offering their services. The IADVL directory of members is not available online. Hence a genuine search for an IADVL member close to some patient's residence does not yield any result. Consequently, the unsuspecting person reaches some "beautician" who labels herself as a "cosmetologist!" Suggestion: Let every official member of the IADVL be noticeable on the worldwide web so that gullible people do not get fleeced by unscrupulous elements and quacks. • Therefore, the IADVL directory should be uploaded for ready access to all · Every member should be given a standard webpage so that the clinic details are easily available · Pharmaceutical sponsors will definitely come forward to support this initiative. · The site should be constantly updated so that changes in addresses can be corrected. • A login name and password can be provided to each member so that patients can email them through the official website increasing the flow of traffic to our site. The member will take full responsibility of furnishing authentic data on the site and IADVL should be indemnified against any false claims.

3. Proposed by Dr. Shyamanta Barua:-Several IADVL State Branches organize Mid-Year or Mid-Term meetings of their respective branches apart from the CUTICONs. I propose the nomenclature of MID CUTICON followed 7 by the name of the State Branch and the year of the meet for such events. For example, the Mid-Year CME of IADVL Delhi State Branch (IADVL DSB) held in 2013 would be called MID CUTICON IADVL DSB 2013. It may be mentioned that IADVL North East States Branch (NEIADVL) has already implemented this following acceptance of my proposal towards this effect at



the GBM of the State Branch last December. Accordingly, the Mid-Term Meet of NEIADVL this year was held in June at Bongaigaon as MID CUTICON NEIADVL 2013. The acceptance of this proposal would be another step towards ushering in a uniform nomenclature and help in archival and referencing of academic and organizational minutes pertaining to such meets.

4. Proposals on fiscal and administrative matters of IADVL (total 7: New 5, forwarded from Ec meet 2)

i) Proposed by Dr. S D N Guptha & Dr. Ramesh Bhat:-We should plan to have our Central Office. Now it is possible only to select one of the State branch IADVL office temporarily by contributing for maintenance. We should have a permanent auditor at this place. We should also have a permanent sb/current a/c with a nationalised bank in the same place where our office will be located. Even our previous audotor opined that this is better. This solves the hassles in transferring the accounts every year. He has to take care of 1. Filing IT returns every year. 2. Filing IJDVL returns. 3. DERMACON accounts We should not have a auditor at place of DERMACON. Office expenditure: The office expenditure should have a maximum cap and this cap has to be decided by Finance committee. (Proposal for need of Central office for IADVL, was sent by Dr Suresh Talwar separately).

ii) Proposal by Dr. RajibGogoi presented by Dr. Atul M. Kochhar :Dr. Rajib Kumar Gogoi, Member, North East States Branch, Dr. Atul M. Kochhar, Member, New Delhi Branch, Dr. KoushikLahiri, Member, West Bengal Branch, Dr. ShyamVerma, Member, Gujarat Branch, Dr. ArijitCoondoo, Member, West Bengal Title: "DERMACON: FISCAL TRANSPARENCY" DERMACON has become a global brand as far as Dermatology conferences are concerned. Organisationally DERMACONs are THE main source of income for IADVL. In recent years we have witnessed many regulatory clauses regarding structure and function of IADVL Same have to be applied on the financial transparency of DERMACON related expenses. This should concentrate not only on the duty of the organizers to a) declare / announce the accounts but also b) The right of the common member to ask for clarifications. Queries raised by members must be answered by the official(s) who the question is aimed at.

We propose the following set of amendments/ guidelines for DERMACON with some proposals for Zonal and State level activities too.

a). Income & Expenditure heads:

We propose that there be a set of fixed/constant Expenditure heads and these be same for all IADVL events. Organizers should be required to keep record of all expenses under these headings. (*This will make "inspection of audit" easy and comparison between subsequent events very clear, thereby discouraging avoidable expenditure.*) We propose the following heads of accounts be adopted for all IADVL conferences / CME programs / Workshops organized at all levels of the association. *Food & Beverages, Transportation, Accommodation, Scientific hall expenses (including audio-visual aids), Cultural events, Printing & Communications, Awards & Mementos, Office expenses and Miscellaneous expenses.* Similarly, Income heads should also be constant and universal for all IADVL events. These may be as follows – *Registration fee, Accommodation fee, Scientific session sponsorship, Exhibition stall sponsorship, Food & Cultural event sponsorship, Advertisements, Seed money from Central Committee, Sale of Food coupons.*



b). **Expenditure under the head of Miscellaneous Expenses** shall not exceed Rs. 2,00,000/- in DERMACON, Rs. 40,000/- in DERMAZONE and Rs.15,000/- in CUTICON.

c). **Selection of Service Providers in DERMACON**: Quotations will be invited by the Organizers from various parties for Event Management, Food catering etc. Kith & kin of Organizing Committee top brass shall not be offered the contracts. All quotations shall be vetted by EC IADVL. EC IADVL shall reserve the right to call such a party/contractor to appear in person, whenever deemed necessary. The organizing committee shall make final decisions based on EC's suggestion. Neither the Organizers nor anybody acting on their behalf shall block hotel rooms for the conference dates en masse in the host city. The Organizing Committee shall sign in an agreement with the EC, IADVL to this effect. On receipt of a formal complaint with substantial evidence about any breach of conduct in this respect by the Organizing Committee, EC IADVL shall hold the right to take punitive measures as per the guidelines mutually agreed upon and documented in the agreement. However, the Organizing Committee may book hotel rooms just sufficient enough to accommodate IADVL officials who are constitutionally entitled free accommodations and invited faculty members to whom the Organizing Committee might have committed free accommodations either in the venue-if the venue happens to be a hotel, or in suitable hotels in the city. 3

d). Ceiling on Cash Transaction: A ceiling on cash transaction with a single party on a single date should be in place and must be strictly followed by the organizers. We propose this at less than Rs. 20,000/- . Any single transaction worth Rs. 20,000/- or more MUST be made by cheques, drafts or by Electronic means of fund transfer only.

e). **Bills & Vouchers**: Every single paisa spent must be supported by a bill/ Invoice. In obvious situations where generation of a bill or an invoice is not possible (e.g. engaging a daily wage labourer to clean up the Org. Com. Office), a written statement must be made by the Treasurer detailing the expenditure. The bill/invoice or the Treasurer's statement must be supported by a conference voucher signed by the payee, Treasurer and counter-signed by Org. Secretary/President.

f). **Money receipts**: All incomes must be supported by Counterfoils of money receipts and against all incomes, money receipts must be issued. It goes unsaid that no cash will be accepted from anybody except during Spot registration and Spot sale of Food coupons which also must be received against money receipts.

g). **Role of IADVL EC in DERMACON accounting** a) The Chairperson, Finance Committee shall be the national Finance Coordinator for DERMACON on behalf of IADVL National executive.

b) The name of the proposed DERMACON auditor has to be sent along with the bid letter for DERMACON. The name of the auditor has to be approved by the GB in the same meeting where the bid is accepted and the name of the Organizing Secretary and Scientific Chairperson is accepted. c) An inspection of book of accounts shall be held at the city of DERMACON by a 3 (three) member jury from IADVL Executive Committee. They will be the Hon. Treasurer, Chairperson- Finance Committee and Immediate Past Chairperson, Finance Committee. This inspection will be done exactly 3 months after the end of DERMACON i.e. before the EC meet in April. Expenses for this inspection shall be borne by the DERMACON organizing committee. If the inspectors have doubts on any point they shall ask the Organizing Secretary in writing to validate the same by showing the relevant document. If even after this, doubts are not cleared then they shall inform the Organizing Secretary about the same in writing, a copy of which shall be sent to the DERMACON auditor. The 3



inspectors shall submit their report (along with objections to DERMACON accounts, if any) to the Executive Committee and the same shall be discussed at the EC meet.

d) The audited DERMACON accounts have to be submitted within six months of DERMACON (calculated from the last day of DERMACON). The same along with the IADVL Finance inspectors report shall be placed on the website immediately, discussed by the Executive Committee and also placed before the subsequent Central Council meeting and General Body meeting for approval. e) If the General Body is not satisfied with the accounts in any way, then it shall have the right to order a re-auditing of accounts by the national IADVL auditor or any other auditor suggested by him (and approved by the EC) at the city of DERMACON. This shall be done with the permission of the CA institute after apprising them about the GB resolution regarding the same. f) If, even after, re-auditing the accounts are not found correct then the national Executive Committee shall have the right to take legal action against the DERMACON organizing committee.

h). **Presence of Organizers in CC/GB meetings**: The organizing secretary and Treasurer must be mandatorily present during the CC and GB meeting when the audited account shall be taken for discussion. The Treasurer of DERMACON shall read out the accounts in both of these two meetings in presence of the Organizing Secretary. If the Treasurer or Organizing Secretary can't attend any of these two meetings due to some genuine problem, he/she must be represented by someone duly authorized by the absentee and the representative shall have to perform the same duties in the meeting including answering questions raised by CC/GB members. The Inspectors too must be present in the same meeting. Any question from any CC/GB member regarding expenses incurred in any head must be replied by the Organizing Secretary or Treasurer. Both of them and the Inspectors must come prepared with the break-up of all heads of Income & Expenditure and must be able to tell the house about all these, when asked for.

i). **Disciplinary actions by CC/GB**: In case the CC/GB is not satisfied with clarifications/explanations given by the Organizing Secretary and Treasurer of DERMACON, the CC/GB shall reserve the right to seek legal advice regarding further action against the concerned officials. CC/GB shall also have the right to take appropriate disciplinary actions against the Inspectors if the Inspectors can't justify their report. We propose that certain strict punitive measures for such a situation should be finalized immediately in a public forum like CC or GBM with input from maximum number of members available.

J) **Date of Implementation of current proposal**: We propose this system be implemented with immediate effect at all levels of IADVL activity and all the past conference accounts which are yet to be accepted by GB/CC/EC be covered by these provisions.

K). **Provision for re-scrutiny**: Competent authorities with democratic and ethical input from members of IADVL should also ensure that wrong doings of recent past are not considered totally immune to questioning just because the accounts have been submitted or accepted. A rational, logical and effective clause to that effect is in order.

L). **Easy and ready access to information**: All data of past conferences (and the future ones) should be on the website, in a language which the 'average common' IADVL member can understand.

iii). Proposal ON AUSREITY MEASURES: Dr. Suresh Talwar: (Based on the CONCLUSION of discussion in the CC group)



Up to 5 years past president/secretary/treasurer be given 100% reimbursement and beyond that be given 50 % reimbursement of travel expenses along with free accommodation. This way helps us in seeking views of the senior office bearers with relatively less burden on IADVL finances. Every state has to evolve and create their financial stability and reduce load of center.

Proposal: Every year we reduce sponsorship by 1, i.e. 2013-5: 2014-4; 2015-3; 2016-2 and so on, and from 2018 all state CC members will be sponsored by state.

iv) PROPOSAL from Dr Kiran Godse: One more way to reduce expenses is to hold CC in metro cities on sunday only so need to spend on accommodation except few with poor connectivity. Hotel near airport is preferred to cut down travelling cost.

Proposal: To hold CC in metro cities or convenient place either alone or in combination with EC depending on the feasibility without combining with the MID DERMACON.

v) DERMACON ACCOUNTS -Dr Suresh Talwar

A. All the balance sheet should be forwarded to the finance committee and their opinion has to be taken. Once they say OK, then only balance sheet be passed .In case of doubt they can seek opinion of professional CA and the fees be reimbursed by IADVL. IADVL accounts, DERMACON, CC/EC meet, MIDDERMACON as well as **journal account** should be screened by them routinely

B. IADVL should also procure a copy of all the agreements with the event manager and the DERMACON organizers so that we can access the proceeds . This should form a part of SOP - to forwardrd a copy to the national executive

C. Forwarding of bimonthly report by conference organizers – Every 2ndmonth conf organizers should forward report of income and expenditure to the national body. This should be routed through the state president / secretary

vi) Proposed by Dr. C.R Srinivas:- (discussed in EC meet) FINANCIAL ACCOUNTS

- (e) The host branch is responsible for all financial matters related to the DERMACON. The IADVL will bear no financial liability of the DERMACON.
- (f) The host state branch should have a Permanent Account No. for income tax. The DERMACON should also have a separate PAN as they will have to pay the income tax and then hand over the savings to the Honorary Treasurer, after the conference.
- (g) It is expected that a minimum 20 % of the total conference collection will be given as savings to IADVL
- (h) An audited income and expenditure account of the conference shall be submitted by the Organizing Committee to the Honorary Treasurer within 6 months. The detailed bank accounts, transactions, and quotations received from event management companies should be submitted to impart transparency to the financial aspects of the DERMACON. It will be submitted for auditing by the IADVL.

Discussion and Result: Accepted by the EC in principle but modalities to be worked out. Dr VK Sharma suggested that a MOU must be signed between the conference organizers and national IADVL Dr Sacchi suggested that in addition even the percentage of total money collected must be earmarked to the national



IADVL. Total collection should exclude money to be paid toward service tax and IT. The house agreed that the signatories of the MOU would be responsible for the correctness and submission of the accounts to IADVL. There has been suggestion that 15% of MIDDERMACON collection should be earmarked to national IADVL. Dr Jha agreed to this suggestion in principle.

Action to be taken in case of default the following action will be initiated at 15 days interval. The Honorary Secretary will write to Organizing Chairpersons reminding them to submit the account. If account is not submitted within 15 days a second reminder will be sent permitting another 15 days time. If still account is not submitted a final reminder will be sent. If still the accounts are not submitted then names of all the members of the local organizing committee will be deleted from all the E group. If still accounts are not submitted the local organizing team will not receive the hard copy of IJDVL. If still the accounts are not submitted the members of local organizing committee will not be allowed to contest elections. If still the accounts are not submitted the similar action in a time bound manner will be taken against EC of the state which has organized the DERMACON.

First Reminder after due date ---->Second Reminder---> 3^{rd} and Final Reminder --->Delete EFacilities --> Stop Journal --> Not eligible to contest --> Action against state EC

Line of action applies to organizing Sec., treasurer and president of the DERMACON: National Auditor Will Be Send To Audit The Account If No A/C Received In 9 Months.

Discussion and Result: Dr Deepak Parish suggested that the balance sheet of DERMACON 2012and audited account to be presented in CC meeting at Patna. This would enable us to discuss the last balance sheet and also look for scope for improvement. It was also suggested that MIDDERMACON expenses should be submitted during subsequent DERMACON. This suggestion was accepted by the EC.

Intimate dates of MIDDERMACON by April. C. Invite proposals for the CC meeting by May end and 30 June would be the deadline of sending the same



6. Proposals on organizing MIDDERMACON (Two proposals) :

Proposal A: MIDDERMACON should be organized by central IADVL EC team Dr Suresh Talwar:

Our objectives of arranging MIDDERMACON are:

1) Generating finance for CC meet. 2) Platform for SIGs to present their work especially those where it is difficult to get sponsorer e.g. Nursing care, Clinical trial etc.

3) Center arranging smaller meeting will give adequate experience, and if it works then annual conference also can be conducted by center. So far we conducted two meetings with this model. At drabad, thanks to Dr Rao we saved around 14 lakhs and hence spend only 3-4 lakhs extra for CC meet. However this year Dr Jha suggested that we may not save more then 9-10 lakhs, from which part will go to state. Thus IADVL is actually in loss.

Proposal – IADVL center should conduct MIDDERMACON Who will conduct it? – President and His EC team Venue- Team can decide anywhere in India except 6 metro. Scientific Part- same Team with help of Academy Timing – Any time Mid-August to Mid-Sept. Local state branch or City branch may be involved, BUT no sharing of revenue.

PROPOSAL B. Road Map to MIDERMACON (MID annual conference of IADVL) **By Ec groups: Objectives**

- To conduct IADVL conferences in smaller centres.
- To facilitate CC MIDERMAMEET(Reduce the expenses)

When to conduct: Aug-Sep (Depending on weather conditions): It can be combined with Zonal/State conferences. The local organisers can have their business meeting in a separate hall; however it should not clash with CC meet. It cannot be held along with any international meet r Zonal meet. (If combined, it would be difficult for accounting purpose and division of profit) MIDDERMACON should be avoided in the Zone where DERMACON was held, unless there is no other bidder.

BIDDING: Like DERMACON- However bidding from states belonging to DERMACON zone , will not be considered, unless there is no other suitable bidder. However connectivity will be important criteria. Venue should be decided just like DERMACON by ballot. <u>Seed Money- Host State will give 5 lakh first, and then 5 by center.</u>

Venue Inspection: The committee of venue inspection consists of President, President-Elect and Hon. Secretary. President can nominate one of EC members in absence of any member. Their travel and stay will be arranged by organizers. Could be by the Vice presidents of national EC.

Organising the Conference: The conference is for two and a half days. First day will be CME. Two topics can be selected and given to SIGs. Next one and half days will be the conference. CME will be from 9.30-12.30 AM and 1.30-4PM.Inauguration at 9AM. After 4 PM on CME day all the committees will meet till night 9PM. Followed by dinner.

CME will be planned by academy. Inauguration should be very simple no guest, president only inaugurates the meeting. The next one and half day program prepared by local scientific committee in consultation with IADVL EC and Academy.



The conference will have lectures, panel discussions, free papers, award papers and posters. Unless we involve members and Residents registration will not be in good no. As it is combined with state or Zonal conference. Orations if any can be allowed.

Scientific Committee: President will be chairman. Other members will be – President elect, Hon. Secretary, Academy chairman and convener, Local scientific committee chairman selected by state and three more members from host state (or from zone if it is merged with CUTIZONE).

CC M (and Mid GBM if required) can take place on 2nd day at 4pm-8pm. and if required next day 9-1pm. Any new Awards or Orations applications will be for MIDERMACON only.

Registration fees: Rs 4000 or 5,000 for delegates. CC members will pay 50% of registration fee only upto early bird registration. After that they will have to pay whatever is fee mentioned for general delegates. Rs 3,000 for PLMs (Residents). No separate registration for CME. CC members will be sponsored by IADVL as it is done now (Travel and stay only). Organisers will provide 2-3 halls for CC meet at no extra cost, along with meal and dinner. Workshop can be conducted by the local org committee. Income so generated will be in MIDDERMACON account and shared

The local organising committee will provide local hospitality only for the 3 Presidents, Hon sec and Treasurer (2-3 days separate rooms). The remaining at the discretion of the Org Comittee. If CC members and state Executives have to be provided local hospitality IADVL should give a sum of Rs 5 Lakhs (non refundable) to the local org committee. Travel can be reimbursed directly by IADVL if required/Possible. **STALLS:** It will be like in any other IADVL conferences

PROFIT Sharing: It will divided 50-50 like the existing norms for DERMAZONEs (50% to the state organising the conference and 50% for the IADVL head quarters. MIDERMACON excess is arrived at after taking care of the accommodation of the CC members by the conference organizers. CONCLUSION: Most of the norms for DERMACON can be followed here also.

ANNEXURE V: RULES FOR IADVL TRAINING FELLOWSHIPS

- 1. The fellowship will be open to any member or provisional life member of the IADVL who is not working in the same institution.
- 2. The awardee must be aged less than 35 years at the time of commencement of his or her fellowship.
- 3. The applicant must specify the course of specialization that he or she intends to undergo and give maximum of two choices.
- 4. The host institution must be ready to accept the awardee.
- 5. The awardee will be selected by a panel on the basis of merit and the possible utility of the training in the discharge of his or her duties. The candidate must apply with full biodata.
- 6. The duration of training will be 4 weeks.
- 7. A panel of members of IADVL constituted from time to time will select the course of training and the corresponding institution. Private institutions are not barred from instituting training fellowships, but they will not be permitted to charge any fee.
- 8. The amount of fellowship will be 10,000/-
- 9. Awardees must give an undertaking for completing the fellowship within the stipulated time, failing which they may not be considered for future fellowships through or from the IADVL.
- 10. The fellowship will be given only after successful completion of the course and on production of a certificate to that effect from the teacher.
- 11. This fellowship amount will be released only after submission of the feedback form from the teacher.
- 12. Selection will be done once a year and announcement would appear in August issue of IADVL News Bulletin. Results would be announced in January, during the National Conference (DERMACON).



Although cosmetically unacceptable, vitiligo patients do not experience significant symptoms, though rarely, itching and burning sensation may occur. regarding this much stigmatized disorder was spread. Advice regarding sunlight, trauma, heredity, and various other factors pertinent to vitiligo were emphasized upon in the presentation. The patients received free medication and were counseled regarding the same. The wonderful response from the patients encourages us to continue spreading and delivering essential information regarding vitiligo and its treatment.




