TREASURER'S NOTE -



It is always difficult to follow in the footsteps of a very efficient person. During the last few months since I have assumed the charge of Treasurer I have tried to emulate my illustrous predecessor as far as possible. As reported earlier the funds of IADVL have been transferred from Bangalore to Kolkata with no loss to IADVL in the form of bank charges.

As per the proposal of Dr. SDN Guptha which was passed at the Midermameet at Hyderabad in July 2005 and by the General Body at Dermacon 2006, a two tier system of auditing has been introduced from this year. The internal audit will be conducted by the auditor at Kolkata and the auditor at Bangalore will audit and submit the Income Tax returns at Bangalore. This will have the desirable effect of making our Accounts absolutely transparent. To provide a further cushioning effect, we have made an arrangement whereby our auditor at Kolkata will go through our accounts every 3 months without taking any extra remuneration.

As reported by Dr. SDN Guptha in his earlier reports, the funds of IADVL can now be judiciously used for newer academic activities. However, unless we earmark some part of our funds and income for academic purpose they might be used up for unexpected purposes. In this context, I would like to inform our members that the Association had to spend about Rs 50,000 to send three observers to Indore for the Madhya Pradesh Branch General Body meeting on May 28, to resolve the crisis regarding the Bhopal bid for Dermacon 2008. Such avoidable expenditure will definitely eat into our hard-earned funds.

In the last few months IADVL has been taken long strides under the stewardsip of our President, Dr. Suresh P Joshipura and our Honorary Secretary, Dr. Koushik Lahiri. I am sure that at the CC Midermameet at Hyderabad fruitful discussions will be held and the important decisions taken, including those on financial matters, will go a long way in strngthening IADVL.

I can mention a few important achievements in last few months

- EC MIDERMAMEET 2006 in Rajkot was very successful in streamlining the policy matters related to IADVL. The details of this important meeting have been published in this issue of IADVL NEWS.
- Membership drive is on an all time high. I started enrolling from life members from 4241.After that within last 5 months we have been able to enroll more than 120 life members and another 120 Associate members. This was possible only because of active support of various state secretaries. A membership form has been attached to this issue of IADVL. My appeal that every member they try to enroh at least one member each. Our motto is 'Each one, bring one.'
- We are following a relentless and continuous process of updating members address. In last few months more than 200 members' addresses have been updated and the process is on.
- A membership card has been issued to all the life members. I acknowledge M/S Ajanta Pharma's support for this.
- The long awaited updated IADVL constitution has been released. The constitution update committee members under the leadership of Dr. K. Siddappa and with active participation of senior members like Dr. R.G. Valia have done a great job and for that ultimately we could bring out the updated version of the constitution. We cannot forget our friend Palsons Drugs contribution in supporting this very important and prestigious project of IADVL. Along with that the members will receive an IADVL car sticker.
- You have a new website now. www.iadvl.org . I sincerely thank all the members of the IADVL Website committee for that. You can now obtain all the necessary information you need about IADVL and more by click of a mouse. You will get information about forthcoming awards, prizes, scholarships, fellowships, any IADVL event, conferences, workshops etc. You can search the whole IADVL Directory online. Even you can read the constitution online. Please join us on the web and enjoy the healthy growth IADVL is enjoying. The more you use the site the better. This is a step in fulfilling our dream of establishing a highly efficient and modernized system to manage the administrative aspects. We are trying to inspire and encourage all the branches and the members to develop an Internet based interaction system with the National office to ensure rapid and effective administration of the association.
- We have been able to re-establish our links with International league of Dermatological societies. we will inform the members as situation unfolds.

- We have been successful in rolling out several scholarships and fellowships for our younger colleagues. Like previous years we continue to have AAD fellowship. This year we could add WCD/ILDS fellowship (details inside). Some more are in the offing.
- IADVL Training fellowship is continuing, we have added some more centers. You will get all the details in this issue.
- IADVL is deeply committed in its ongoing endeavor to give dermatology its due recognition. With the help of the state branches we have observed MCI Issue month in July. IADVL executives have met important persons, MCI council members, vice-chancellors to sensitize them to the cause of Dermatology and importance of such a vital and composite discipline.
- Vitiligo day, HIV Day, Leprosy Day, IADVL Day, IADVL has taken some measures to increase public awareness about skin diseases by mass campaign. Observing different days are steps in that direction.
 - "Vitiligo day" -As per the resolution of closing year 2005 AGBM it was finally decided in Rajkot EC that from now on IADVL will observe "Vitiligo day" every year on 19th May. With or without the help of pharmaceutical companies IADVL will launch a media campaign, organize lectures, meet the public, organize free medical camps etc to do away with the stigma and unscientific ropaganda. This can also be done at the individual level but from next year 2007 each state branch will be in charge of organizing the campaign.
 - Every year IADVL will also observe Leprosy day on 30th January, HIV and AIDS day on 1st
 December to establish the composite nature of our discipline and sensitize common people and different Government/non government agencies about the paramount importance of our subjects.
 - IADVL was established in the present form in Uadipur on 28th January 1973
 - It has been decided to observe IADVL day on 28th January every year.
- Matters related to the proposed IADVL Academy/Academic council and special interest groups had been accepted in principle in the AGBM of concluding year 2005 and Dr. Arun Inamadar, Vice-President, IADVL had been entrusted with the responsibility to frame a detailed structured guideline to be presented for discussion in EC MIDERMAMEET and CC MIDERMAMEET. Dr. Inamadar has prepared an exhaustive, detailed and structured draft proposal and presented in the EC MIDERMAMEET 2006. It was accepted in principle and was referred to the CC meeting for further discussion.

In the combined CCM and AGBM of 2006 at Hyderabad the proposal of IADVL MP Branch was accepted and accordingly it was approved that the **36th National conference** (DERMACON 2008) will be held at Bhopal. But even almost

three months after that no name of the **IADVL** organizing Secretary reached Secretariat officially. Only there were some conflicting statements of the present and immediate past office-bearers of M. P. State IADVL. On this backdrop President Dr. Suresh P. Joshipura requested IADVL, MP State branch to call an extraordinary GBM to solve the problem amicably. But due to the lack of consensus for the venue to hold extraordinary GBM, the MP branch failed to organize that Extraordinary GBM informed the National Body accordingly.

Then the matter was discussed and analyzed at length at the EC MIDERMAMEET 2006.

It was resolved that National IADVL will once again request MP state to convene an extraordinary General Body Meeting of the IADVL, M.P. State branch with the express purpose of nominating an organizing secretary for the conference in 2008.

It was also resolved to send a high level arbitration committee of three senior past Presidents of National IADVL at the proposed state EGBM. This is a part of sincere, continuous and ongoing endeavour on the part of National IADVL to help resolving the matter harmoniously to organize DERMACON 2008 in a decent, integrated and dignified manner. Also this was a measure of opportunity to MP State Branch to avoid any complaint on their part to resolve this unprecedented and undesirable constitutional crisis.

That meeting was held in Indore on 28th of April 2006. Following resolutions have been put to vote and approved amongst 40 members who attended the EGBM.

- a. House by majority vote decided not to have an organizing secretary from Bhopal for DERMACON 2008
- b. House unanimously approved to withdraw their bid for Bhopal as the venue for DERMACON 2008.

This was communicated to the National IADVL Secretariat officially.

In view of the fact that IADVL MP State branch has officially withdrawn its bid proposal to hold 36th National Conference of IADVL (DERMACON 2008) in Bhopal, an extraordinary General Body Meeting has to be convened as under with the agenda: To select and to decide the Venue for 36th National Conference of IADVL (DERMACON 2008) and organizing Secretary from the proposed host city.

- Needless to mention, the mutual support, cooperation and coordination between the National Secretariat and the state branches is of paramount importance to run the association smoothly with a definite and constructive commitment for excellence. The meeting with the state Presidents and Secretaries is an exercise in that direction. We are planning to continue with this in future as well.
- Our other projects like the very important IADVL-GSK National quiz, Faculty forum, drug formulary etc will continue with the same zeal and prestige as before.

On behalf of the Association and the National Executive for the year 2005, I welcome all the central council members for the CC MIDERMAMEET 2006 on 5th and 6th of August at Hyderabad, the midterm CC meeting of IADVL which is an ongoing process of continued and streamlined IADVL activity. I sincerely appreciate Dr. Reddy's Laboratories for extending all sorts of support and hospitality for the meeting.

- Public awareness program on Vitiligo and other diseases, and observing 'Vitiligo day' and other days.
- d. IADVL Fellowship programe including SAARC countries
- e. Preview of preparation of book on ethical issues.
- f. Liaison with NACO, progress report
- g. Faculty forum, progress report
- h. IADVL-GSK National Quiz programme. 2006
- a. MCI ISSUE and 'MCI issue' month including PG course updates and UG separate paper

Dr. V.P. Kuriyipe started the discussion and informed about the work done in 2005.

Dr. Nitin Vohra outlined the situation in relation to MCI and stressed on the need on continuous and systematic pressure on MCI regarding introduction of a separate undergraduate paper on Dermatology and uniform and updated post graduate course in Dermatology across the country.

Dr. Jayakar Thomas, Dr. Sangeeta Amladi, Dr. Hemangi Jerajani, Dr. Deepak Parikh, Dr. Sanjeev Handa, Dr. Rui Fernandez, Dr. R.G. Valia and Dr. Sacchidanand discussed the matter in detail along with Dr. Joshipura and Dr. Koushik Lahiri.

- **Dr. Jayakar Thomas** stressed the need of observing Dermatology week to sensitize concerned authorities in Government and MCI.
- **Dr. Sangeeta Amladi** highlighted the need of a uniform PG curriculum with specification (no. of faculty/units etc) of PG teaching departments, uniform nomenclature of PG qualification and need of making rotating internship compulsory and the UG level.
- **Dr. Hema Jerajani** expressed her concern about very less number of PG trainees per year and uniformity of syllabus.
- **Dr. Joshipura** suggested involving IADVL Faculty forum about this,
- **Dr. Koushik Lahiri** wanted to know how much progress was made after last year EC regarding these matters. Reminded all about the recommendations of IADVL Academic Council headed by Dr. Jayakar Thomas in 2005 and opined that IADVL should continue to work to sensitize different agencies in Government and create awareness about the subject,

(which comprises of 25% of all Medical ailments)among common people to reach the final goal of giving Dermatology its due status and importance both in UG and PG level.

- Dr. Sanjeev Handa opined for a better teacher student ratio and uniform course.
- **Dr. R.G. Valia** reminded that Dermatology is mainly an OPD based subject. So number of OPD patients managed should come into consideration to ascertain its due importance
- **Dr. Sacchidanand** informed the house that Psychiatrists are taking the same agenda very seriously and taking legal options.
- **Dr. Nitin** put forward his remarks on these and observed that the nomenclature of qualifications recognized by MCI cannot change as those are recognized globally, as it is. Planning commission recommended against any more new Medical Colleges and courses

He reminded everybody that MCI is only a recommending body and final authority is with the Government.

Finally it was resolved that

- o IADVL will observe MCI issue month in JULY.
- IADVL, both at the National and State Levels will try to meet MCI Executive Council members and important persons concerned to sensitize them about the cause of Dermatology in July.
- IADVL will try to get an appointment from the Union Minister of Health and Family Welfare to follow up the matter.
- Dr. Nitin Vohra and Dr. V.K. Jain are requested to put the matters related to Dermatology in the agenda of MCI meeting.
- a. Web site revamping project

Dr. Koushik Lahiri appraised the members about

- Website Project proposal (already published in IADVL NEWS, Vol 2, Issue 1, Page 47-48)
- Three quotations as under:
 - i3 Brains solution, Ahmedabad- Rs, 1,05,000/-
 - FM Infomatic Solutions, Aligarh- Rs. 25,250/-
 - dnetdesign, Mumbai Rs. 70,000/-
- Dr. Lahiri also informed the house that of these three, dnetdesign, Mumbai is the authorized and approved vendor by the sponsor P & G.
 - This will ensure quality and to minimize our responsibility.
 - Moreover, billing related matter won't be our headache as it will be settled between P& G and their approved vendor.
 - We would have the upper hand if we face any problem with service
 - P& G has assured us about the capability and timeliness of dnetdesign.

He also communicated the conditions put forward by the IADVL-Website revamp committee:

 The site should be designed as per our specifications and not as per the sponsors.

- The secretary must get one-to-one with the website developer and tell him about our requirements and he should be willing to tow our line.
- The sponsors should be clearly informed that an alternative lower cost option exists, but to make it convenient for them, we are going along with their developer.
- Site update will be a continuous process, may be handled from Secretariat.
- Since he is the sponsors' man, the sponsors will have to ensure the quality of the final site and its regular maintenance.

Dr. Sacchidanand enquired if the site can be maintained by IADVL.

Dr. Lahiri reminded that General body has given its consent for the creation of website for our Association provided the association does not have to spend for it. It authorized the Honorary General Secretary to raise the necessary fund.

Dr. Chetan Oberai, Dr. Janak Thakkar, Dr. Ameet Valia, Dr. Deepak Parikh, Dr. Arijit Coondoo and Dr. S DN Guptha took part in discussion and finally considering all the pros and cons it was resolved as below: dnetdesign of Mumbai will be entrusted to revamp the website of IADVL. It was also resolved to have a formal contract between P&G and IADVL about this project.

b. Public awareness program on Vitiligo and other diseases, and observing 'Vitiligo day' and other days.

Dr. Sacchidanand expressed his concern about unethical and unscientific propaganda by quacks and so called homeopths in this regard and proposed that through continuous public awareness program IADVL can counter this.

Dr. Rui Fernandez, Dr. Arijit Coondoo, Dr. Sangeeta Amladi and Dr. Nitin Vohra took part in discussion.

Dr. R.G.Valia and Dr. Ameet Valia explored the possibility of IADVL taking any legal action and opined that IADVL should have a legal cell to deal with these types of issues.

Dr. Sacchidanand opines to assign the job to some committee.

Dr. Joshipura informed the members that Dr. Raghunandan Torsekar committee has already started preparing materials for development of resources for academic/clinical and public awareness material.

Dr. Koushik Lahiri observed that we already have $HIV\ day\ on\ 1^{st}\ Dec,$ Leprosy day on $30^{th}\ January.$

We should also have a VITILIGO DAY.

This proposal of Dr. Venkatram Mysore was already passed in the AGBM of concluding year 2005 at Hyderabad (Vide IADVL NEWS, Vol 1, Issue 1, and Page 32)

Dr. Lahiri proposed that we can observe 19th May as Vitiligo day every vear.

Incidentally on this day the legendary and internationally reputed worker on Vitiligo **Dr. Ajit Kumar Dutta** breathed his last in 2004. To commemorate that, he proposed all IADVL state branches will observe Vitiligo day every year on 19th May. He also informed the house that IADVL, WB will start observing Vitiligo day from 19th May this year.

Dr. Lahiri also proposed as IADVL was established in the present form in Uadipur on 28th January 1973

 IADVL day can be observed on 28th January every year

He suggested it can start from Chennai DERMACON 2007.

Dr. Jayakar Thomas agreed to do something without disturbing/diluting the planned scientific program of the conference.

Dr. Lahiri proposed that from now on every year IADVL state/city/town branches can observe:

- Vitiligo day-19th May
- HIV & AIDS day-1st December
- Leprosy day- 30th January

He proposed that this is a step to increase public awareness about skin diseases by mass campaign.

IADVL with or without the help of pharmaceutical companies will launch a media campaign, organize lectures, meet the public, organize free medical camps etc.

This can also be done at the individual level but from next year 2007 each state branch will be in charge of organizing the campaign.

After some discussion this proposal was accepted.

discussed about various details about this program, quality assessment of the centers, evaluation by IADVL, redefining some rules and regulations etc.

The house accepted these additional centers.

SARAD exchange fellowship program.

Dr. K.K. Rajababu, President of SARAD outlined the fellowship program.

He proposed 4 dermatologists from each country will travel to other SAARC countries. i.e Nepal, Pakistan, Bangladesh and Pakistan. Travel expenses will be taken care of by the countries concerned and local accommodation by the selected Fellowship centers. He has also suggested to identify some centers of excellence from India.

Dr. Sacchidanand, SAARC Secretary General has requested for some budgetary allocation for this fellowship program.

The proposal was accepted in principle but various matters related to it will need some more discussion. Mechanisms of selection of centers, selection of candidates and period of fellowship all will have to be decided.

Dr. Joshipura, Dr. J. Thomas, Dr. Jerajani, Dr. Lahiri, Dr. Handa, Dr. Oberai, Dr. Amladi, Dr. Coondoo and Dr.S D N Guptha took part in discussion.

IADVL-BAD exchange program

In response to Dr. Joshipura's Presidential speech in Hyderabad during DERMACON 2006 recently there was some communication from his British Counterpart Dr. Robin Graham-Brown , the President of British Assoiation of Dermatologists(BAD) regarding a probable exchange between Indian and British Dermatology trainees. Dr. Joshipura appraises the house about it.

It was resolved that IADVL will extend waiver of registration fee and accommodation (twin share basis) for two Dermatology Residents from UK formally nominated/selected by BAD. They will be participating by presenting papers/posters in the National Conference of IADVL (DERMACON 2007) In Chennai.

Dr. Jayakar Thomas suggested that the cut off dates for receiving the nominations from BAD will be 31st August 2006.

This invitation is valid only for DERMACON 2007.

It was also observed that by initiating this exchange program IADVL will in turn expect similar reciprocation from their British counterpart.

b. Preview of preparation of book on ethical issues.

Dr. Rajababu informs the house that as per the decision taken in the AGBM the project of IADVL book on consumer protection act, ethical issues and medicolegal aspects is being prepared by the Chairperson of Ethical issue committee Dr. P. Srinivas.

The contributors' names were discussed chapter by chapter. The book is scheduled to be released in Hyderabad.

c. Liaison with NACO, progress report

This was postponed as the report was not available.

a. IADVL-Faculty forum, progress report

Dr. H.R. Jerajani and Dr. Sangeeta Amladi took part in discussion and it was decided that if and when the proposed academic council under IADVL is formed IADVL faculty forum will work in tandem with that to deal with matters related to MCI more effectively and systematically.

b. IADVL-GSK National Quiz programme. 2006

Dr. S. Sacchidanand submitted his report for IADVL-GSK quiz for 2005.

Dr. Suresh Joshipure, Dr. Kuriyipe, Dr. Handa, Dr. Jerajani and Dr.Jayakar Thomas participated in the discussion.

The members stressed on standardization of questions. Written MCQ type of questions in the initial rounds, question bank, involving the faculties all were discussed.

It was suggested to have state level quiz at the time of state conferences (CUTICON) and Zonal level quiz at the time of zonal conferences (DERMAZONE).

It was also resolved that as with any other quizzes quiz masters' decision is final and binding.

1. Matters related to DERMACON 2007

The Chairperson of Organizing Committee Dr. Jayakar Thomas welcomed all the members to Chennai. He gave a brief overview of the conference.

There will be only two parallel sessions and only one plenary session. He has assured that proper arrangement for business meetings of IADVL during DERMACON 2007 will be made.

He suggested having IADVL quiz on penultimate day or on the first day after Ambady oration.

He has announced 50% reduction of prices for bookstalls and extended completely free stalls to Bhalani Publications to sell only IADVL books.

There will be a total of three free bookstalls and they will be instructed to give discounts to IADVL members.

Tentatively it was decided to have central Scientific committee meeting on the first week of September.

Dr. Joshipura appreciated the gesture of Dr. Rajababu for giving apex fare to the central scientific committee members last for Hyderabad conference.

2. Matters related to DERMACON 2008

[Tthe matter related to 36th National conference was included in the agenda of AGBM of 2006 at Hyderabad and after discussion and assurance to follow the guidelines prescribed in the Constitution in this regard, ultimately the proposal of IADVL MP Branch was accepted and accordingly it was approved that the 36th National conference (DERMACON 2008) will be held at Bhopal. But even almost three months after that no name of the organizing Secretary reached IADVL Secretariat officially.]

Dr. Koushik Lahiri gave a detailed and chronological account of events related to DERMACON 2008.

All the documents related to the issue were placed before the members of the committee. All the members participated and the matter was discussed at length.

The EC took note of the conflicting statements of the present and immediate past office-bearers of M.P.State IADVL and their failure to name an organizing secretary acceptable to all. The members have registered their discontent about the course of events.

However, it was the unanimous wish of the EC members that, before any drastic action is taken, IADVL, M.P. State branch should be given one more chance to resolve their differences and be given another opportunity to name the organizing secretary for DERMACON 2008.

It was resolved that National IADVL will once again request MP state to convene an extraordinary General Body Meeting of the IADVL, M.P. State branch with the express purpose of nominating an organizing secretary for the conference in 2008.

It was also resolved to send a high level arbitration committee of three senior past Presidents of National IADVL (Dr. R.G. Valia, Dr. K. K. Rajababu and Dr. A.K. Bajaj) to be present at the proposed state EGBM and take stock of the situation and report to the National Executive committee. This is a part of sincere, continuous and ongoing endeavour on the part of National IADVL to help resolving the matter amicably.

IADVL National executives wished that MP state branch will be able to resolve the matter harmoniously and will organize DERMACON 2008 in a decent, integrated and dignified manner.

It was also observed that this is a measure of opportunity to MP State Branch to avoid any complaint on their part to resolve this unprecedented and undesirable constitutional crisis, failing which National IADVL will be constrained to consider painful necessary action in this regard.

3. IADVL-Academy matter-discussion on Dr. Arun Inamadar's Report.

The draft proposal was discussed and analyzed in details. Dr. Jerajani, Dr. Amladi, Dr. Fernandez, Dr. Lahiri, Dr. Rajababu, Dr. Parikh aprticiapted in the discussion.

Ultimately Dr. Joshipure concluded that principally the idea of an academic council under IADVL/IADVL Academy is acceptable and agreeable but it requires lots of inputs before IADVL can finally accept for implementation.

The matter was referred to CC MIDERMAMEET 2006 for discussion.

1. IADVL Constitution update

Dr. R.G. Valia, senior member of the IADVL constitution update committee appraised the members that last time IADVL constitution was released incorporating all the updates till 2000.

Later it was updated incorporating upto 2002. But that version was not printed.

Dr. Koushik Lahiri requested the IADVL- Constitution committee to update and incorporate all the resolution passed/accepted between 2002 and 2006 and come up with the final version urgently. So that it can be released without delay.

Dr. Lahiri informed that he has handed over hard copies of the corrected constitution (as received from Dr. S. Sacchidanand) and minutes of all the GB meetings from 2002 to 2006 to all the members of IADVL-Constitution committee. He has also compiled all these in soft format and handed over to each and every members of the constitution committee

He has also requested that he should receive the corrected and updated version of the constitution in soft version within a month form now to expedite the process of printing.

2. WCD/ILDS Scholarship program-Formulation of Guideline

Dr. Koushik Lahiri informed the EC members that during DERMACON 2006 at Hyderabad the Executives from WCD 2007, Buenos Aires Argentina, Dr. Adrian Pierini and Dr. Fernando Stengel had a meeting with IADVL executives on the sidelines of the conference. There WCD executives offered 40 full ILDS scholarships for young Indian dermatologists. Scholarships include travel expenses, accommodation and registration fee. The selected candidates will have to take part in scientific program of the conference by oral/poster presentation.

This list has to be prepared by IADVL based on application invited.

Based on WCD/ILDS guideline applications are to be invited (application details have been included in this news letter and also in May issue of IJDVL)

Dr. Lahiri informed that WCD has agreed to accept names of the selected candidates sent on or before 31st December.

It was decided that the cut-off date for accepting application for consideration for this grant by IADVL secretariat will be fixed as 31st September 2006.

The panel of judges has already been selected in the combined CCM and AGBM of the commencing year 2006. They are Dr. Suresh Joshipura, Dr. V.P. Kuriype, Dr. Chetan Oberai, Dr. Rui. J. Fernandez and Dr. A.K. Bajaj.

3. Matters related to CC MIDERMAMEET 2006 : Date, Venue, Agenda

Dr. Koushik Lahiri informed the EC members that it has been tentatively decided that the dates will be 5th and 6th August 2006(Saturday and Sunday). The Venue is Hyderabad. The exact place of the meeting will be notified in due course of time. He proposed to have a meeting of the state branch Presidents and Secretaries in Hyderabad as well.

It may be mentioned that these mid term CC meeting is a constitutional exercise.

After some discussion it was unanimously decided that CC MIDERMAMEET 2006 will be held on 5th and 6th of August at Hyderabad.

It was also decided to have a meeting with the state Branch Presidents and Secretaries on 5th August afternoon.

If situation arises an extraordinary general body meeting will also be convened after the CC meeting is over.

The following members will be invited for the CC MIDERMAMEET 2006:

- 1. IADVL National Executives 2006
- 2. The Presidents and Secretaries of all state branches
- 3. The central council members of all state branches
- All the past Presidents, past Honorary General Secretaries and past Honorary Treasurers of IADVL as ex-officio(in addition to last years list, past Treasurers were also included)

- National IADVL will take care of travel expenses (apex air fare) of current National Executives.

- Establishing a rapid communication system among the National Executives and state Secretaries and Presidents to promote collective leadership.

The house congratulated Dr. Lahiri and Dr. Coondoo for their efforts.

2. Matter related to finances and financial committee

Dr. S.D.N. Guptha, Chairperson, IADVL, finance committee gave a brief over view and remarked that to avoid taxation IADVL should spend 85% of the total income. The Honorary Treasurer, Dr. Arijit Coondoo opined that IADVL is in fact overspending and IJDVL is spending less. IJDVL should also be allowed to spend more. He concluded that the main source of income of IADVL is from the conferences. He suggested that while sending proposals to hold National conference the state branch should also have a PAN card and before handing over the money to National IADVL they should pay the tax with that. That may lessen the burden on National IADVL. The house appreciated this logic and accepted this proposal in principle.

3. Matters related to IADVL Text Book

Dr. R.G. Valia suggested having constitutional amendment for the text book to include the governing policy about the IADVL Text book in the constitution.

Dr. Koushik Lahiri pointed out that his detailed proposal was published in IADVL NEWS (Vol 2, issue 1) and was accepted by the CC and GB of the closing year 2005 for inclusion in the constitution (Page 23 and 31 respectively)

4. Matters related to IJDVL

Dr. Uday Khopkar, Chief editor of IJDVL was absent so this was defreed to CC MIDERMAMEET 2006

5. Proposals from the EC members

All the proposals sent by Dr. Sacchidanand, Dr. Koushik Lahiri, Dr. Arijit Coondoo and Dr. SDN Guptha was referred to the constitution committee as all these were related to constitutional amendment. (IADVL NEWS, Vol 2, Issue 1, Page51-52). The matters will again be taken up for discussion in CC MIDERMAMEET 2006

6. Any other matter with the permission of the Chair

i. Matters related to the combined North Branch of IADVL (incorporating Punjab, Himachal Pradesh, Chandigarh)

After some discussion, this was referred to the Midterm CC meeting.

ii. IADVL-ILA liaison:

Dr. Chetan Oberai informed the members that we have received a mail from Dr. Noordeen, the President of International Leprosy Association (ILA) to initiate a better dialogue between dermatologists(IADVL) and Leprologists(IAL) and thus contribute positively and effectively to the ultimate elimination of the disease from India

He has proposed to organize a workshop between participants from the two organizations i.e. IADVL and IAL with no more than 20 participants so that in-depth discussions are possible. It is expected that the cost of the participants from the two associations will be borne by the respective associations. It may be necessary to prepare a working paper in advance of the workshop.

The matter was agreed upon and accepted in principle. Dr. Joshipura has requested Dr. Jayakar Thomas , Dr. Chetan Oberai and Dr. Kuriyipe to formulate some road map in this regard.

Dr. Koushik Lahiri rendered the vote of thanks. He thanked Dr. Suresh Joshipura and his team, especially Dr. Janak Thakkar for their excellent arrangements and hospitality. He thanked all the EC members and special invitees who had taken time off from their busy schedule to attend the meeting and contribute effectively. He also appreciated the nice gesture of Dr.Reddys' Lab for extending their logistic support towards success of the meeting.

The meeting ended at 2.15 PM.

PROPOSALS FOR CC MIDERMAMEET 2006

Dr.S.Sacchidanand (LM/KT/1937)

 The tenure of the Honorary General Secretary and Honorary Treasurer of IADVL should be raised from two years to three years. It takes at least six months to one year to understand the intricacies of the post and by the time you can implement something the tenure gets over. Hence three years is a reasonable period for the above posts. I propose that, if approved, this amendment should apply to the current Office-bearers itself.

2. Regarding IADVL - ELECTIONS:

Huge expenditure on IADVL elections can be saved if we follow the KT branch model of nominating the office-bearers.

The model working in KT branch is as follows:

The individual interested in serving IADVL (read KT branch) would be inducted as Joint secretary during the Annual General Body Meeting that is held every year in May.

After finishing two years term as Joint secretary and meanwhile having learnt the nuances of the secretariship, he is elevated to the post of Honorary Secretary cum Treasurer; This would be for another two years term;

Later the Secretary gets elevated to the post of Vice-President; KT branch has two Vice-Presidents; We have made provision for inducting some senior IADVL member as Vice-President directly at this point; The choice of Vice-President each year is from the state hosting the conference. Hence there will be one Vice-President inducted from Karnataka this year and from Tamil Nadu next year.

The Senior Vice-President becomes the President of KT branch next year and the Junior Vice-President (Honorary secretary cum Treasurer) is elevated to his post; (Though officially these posts are not designated as Senior and Junior; it only designates the time of induction of the two Vice-presidents)

This model is working out very well in KT branch and there is no animosity at all; More importantly there are no elections at all; Hence no expenditure;

The same model could be tried at National level as well;

By this we can ensure:

- a. There are no elections
- b. Huge expenditures can be avoided
- c. We can ensure individuals genuinely interested in IADVL activities taking up the post from the lower rung, get trained in the process and then get elevated.
- d. An individual starting as Joint secretary would require at least 6 - 7 years before he can become President of IADVL;
- e. Above all we can have consensus candidates getting into these posts;
- f. The Organising Secretary of the DERMACON could be inducted as Joint Secretary at the National level; and the Organising Committee Chairperson could be inducted as Vice-President (Junior) for that current year;

3. NATIONAL CONFERENCE:

- a. We can show great honor to our fellow colleagues by printing the BIO-DATA of Dr. K. C. Kandhari award winner; Dr. J. C. Shroff memorial award and Dr. L. N. Sinha memorial award for a young Dermatologist.
- b. A brief bio-data of the awardees of AMBADY ORATION, IADVL - GSK and IADVL-Fulford orations can also be printed in the souvenir for posterity sake.
- c. The mementos given during the conferences should either be dispensed with or if given it should be "small" enough to be carried back. Sometimes "big" and "very big" mementos are given which cannot be carried back at all. Sometimes the mementos get damaged during the transit and hence do not serve any purpose at all.d. Mentioning of AM membership to be made mandatory for participants in the Awards paper session and for any participation during DERMACON (like quiz program, free paper session and for poster presentation.) This will increase the awareness about IADVL conferences and will also encourage postgraduates to become IADVL members compulsorily.

4. Zonal branches of IADVL:

- a) The President / Vice President and Secretary of the Zonal branch, should be selected from the Elected / Nominated Office-bearers of the branches itself for that current year.
- b) The enrolment of members and such other activities should still be rested with the State Secretaries and not the Zonal Secretary. We should not create another power centre, which will add to the confusion.
- c) The Zonal branches can get together for organising DERMAZONE conferences once in two years and hence the term of these officebearers should be for two years.
- d) They could rotate the office and office-bearers of the zone from amongst the constituent branches itself.
- e) They can still be members of the CCM as long as they are office-bearers of the State branch and hence can attend ECM / CCM and Midermameet of that particular year.

2. Restructuring of business meeting schedule of

Since last couple of years we are having one M idterm CC and since last year one (ONLY) Midterm EC.

In the National conference we have the following sequence of business meetings

- · CCM for the closing year
- GBM for the closing year
- CCM+GBM for the commencing year

Now after that we are having one midterm EC, and one midterm CC.

So, now we have THREE CCM, TWO GBM but ONLY ONE ECM in a year.

- We propose, we should have at least another **EC** during DERMACON (preferably on the CME day) to discuss all the matters before going to the GB.
- Also, after the midterm CC, logically, we SHOULD hold one GB. Both the other two CCM are followed by GB. But that is practically not possible.
- So, can we go straight to the GB of the closing vear during DERMACON without another CC? (We have already discussed the matters once in the midterm CC.) What is the logic of holding two CCM one after another? This is nothing but wastage of time. Both the minutes are almost photocopies of each other. This year there was obvious displeasure among members for the timing of closing year's business meetings which consumed the whole of CME day!

A CCM should, IDEALLY AND LOGICALLY be followed by a GBM to reach a logical conclusion of the matters discussed and resolutions tabled.

Also there is a need of a separate CCM of the commencing year.

So we propose the new calendar of business events of IADVL

- 1. One EC in the morning hours of CME day(11am-1pm) during DERMACON
- 2. Closing years GB on the CME day.(4-7pm) during DERMACON
- Commencing years CCM on the penultimate day(3-4 pm) during DERMACON
- Commencing years GBM on the penultimate day(5-7 pm) during DERMACON
- EC MIDERMAMEET in April
- 6. CC MIDERMAMEET in August

That makes 2 EC, 2 CC and 2 GB.

Dr. Arijit Coondoo(LM/WB-2364)

- Only members of IADVL can be registered as delegates at DERMACON . No non-member can register as a delegate except delegates from SARAD countries and other foreign delegates. In the registration from the LM must quote his membership number and the OM must attach a photocopy of his or her current year's receipt. This step may help in reducing the numbers of tourist delegates.
- Pharmaceutical companies will be requested not to hold parallel dinners on the day of the pre-DERMACON CME and 1st and 2nd day of DERMACON within a specified diatance (e.g. 200 Kms) of the venue of DERMACON. Holding of parallel dinners (there were at least 3 such on Day 1 of DERMACON 2006) is detrimental to the interests of the sponsors of the official dinner of that particular day. If this practice continues then a time may come when no company will be interested in sponsoring official dinners or banquets.
- **Zonal branches**: To provide for easier management of the affairs of the Association and also to bring transparency into the organization of DERMAZONES the country can be divided into 5 zones: Central, East





North, South and West. Each zone will have under its umbrella a number of states (4 -6). The zonal committee will be elected by a general body comprising of members of these states. This zonal body will be responsible for holding the zonal conferences - the audited accounts of these conferences will be passed by the general body of the zonal members and the profits will be shared by all the member branches according to a formula to be decided by them. In addition the zonal committee will also act as a conduit between the member branches and the zonal co-ordinators appointed by the National **IADVL**

The working year for IADVL National Executive shall henceforth be in accordance with the Financial Year of the Association i.e. from April 1 of one year to March 31 of the next year. The incoming office-bearers will be installed at DERMACON but the new National Executive shall start functioning from April1 of that year.

Explanation:

OLD DRUG

According to the Constitution of IADVL, the cut-off dates for Account, Audits, Membership (to be a valid voter) etc. is March 31. The outgoing Secretary and Treasurer deal with all official matters for 10 months of a particular year - yet the onus for Auditing, completion of membership etc. lies with the incoming officebearers who are new to the job and are not responsible for whatever happened during the 1st 10 months of the financial year. The transfer of funds, official matters etc. can be done more smoothly if the new Secretary and Treasurer start off from a new Financial and Association year. From DERMACON till March 31 they can be designated as Hon. Secretaryelect, Hon. Treasurer-elect etc. They can spend a fruitful 2 months learning the ropes of the job from the outgoing office-bearers. This, in turn will facilitate the smooth charge hand-over and functioning of the Association

Dr. S D N Guptha (LM/KT-1892)

As we all know that at least two dozens of medals and trophies are distributed in the National conference. As a practice the Honorary General secretary carries all these from his place to the venue. In the transit some of these may get damaged. Some of these are life time awards. Also added to this is the confusion while distributing these by the event manager at the time of the valedictory function. Hence I suggest that future DERMACON organizers may arrange the medals, mementos and trophies at the venue based on a list sent by the Honorary General Secretary well in advance. National IADVL shall naturally bear the cost. This practice may put to an end of the unnecessary and avoidable damage and confusion of awards/mementos etc.

LEGAL STATUS: the old brand names are at present containing different formulations compared to earlier formulations but by promoting with old brand name giving false impression as if they are containing the original formulation.

As per the Drug and Magic Remedies Act 1954 Sec 4 (a) and (c) this is illegal

The Section is as follows.

- 4. Subject to the provisions of this Act, no person shall take any part in the publication of any advertisement relating to drug if the advertisement contains any matter which
 - directly or indirectly gives a false impression regarding the true charector of the drug or
 - (b) makes a false claim for the drug
 - (c) is other wise false or misleading in any material particular

Such actions are liable to be punished under section 9. As their products are carrying old brand names with changed formulation.

Hence I request you to table the issue in the agenda and recommend strongly to approach the Govt of India and Drug Controlling authorities demanding strict disciplinary action or any action as suggested by the Hon, ble IADVL members.

IADVL ACADEMIC COUNCIL

(Prepared with reference to Annexure I [(II) and (IV)] of the IADVL constitution)

Vision:

- 1. Promote the highest possible standards in clinical practice, education and research in dermatology and related disciplines
- 2. Unification and representation of the specialty
- 3. Support and enhance patient care and promote the public interest relating to dermatology.

Organization of the Council:

Chair person: Dermatologist of repute with sound academic background.

Co ordinator: One young dermatologist with bright academic background.

He will work in co ordination with IADVL Secretary

Board Members: Eminent and erudite academicians from different zones of the country are selected. Two each from north, south, east, west, central zone / armed forces (10 Members) should be appointed every year (Total 30 members). Members should have overlapping tenures (3 years each) with a third of the members retiring every year in rotation. While appointing members care should be taken to give roughly equal representation to senior and junior members (above and below 40 years)

Ex Officio members: JADVL President, Secretary and JDVL Editor.

The GB will appoint chair person and secretary for a period of three years.

Chair person and secretary in consultation with IADVL IJDVL Editor will choose / President, Secretary and elect board members. Members of the Board are elected for a three year term. Members of the councils who finish their tenure are eligible for re-election but this should be subject to confirmation by the general body meeting of IADVL.

Functional obligations of the council:

The proposed academic council is not a parallel body of IADVL. IADVL will remain the ultimate executive body. Since the functions of the current academic committee of the IADVL are overlapping it will cease to exist after the formation of the council. This is only to avoid confusion of sphere of activity and members of the current academic committee who are interested in continuing into the council should be taken in as members of the council.

It will give IADVL suggestions regarding overall academic development in dermatology and related subjects of the specialty.

Help IADVL in different issues like MCI (Academic part e.g. syllabus of UG & PG courses, compulsory internship),

Help in formulating therapeutic guidelines / drug formularies / patient education leaflets and other materials.

To coordinate with proposed Special Interest Groups (SIG) to conduct CME / workshops / symposia / PG clinical case teaching programmes by providing resource persons and other academic inputs. IADVL should consider sanctioning of grants (to a pre-defined extent) for conduction of such meetings as many of the academic causes are probably kept on the backburner for lack of sponsorships. Academic council should have the power to recommend such sponsorships to a pre-defined extent e.g. It should

have the power to grant Rs. 20000/- each for any five meetings every year. The meetings should pursue causes not usually covered elsewhere. E.g. courses in Dermato-epidemiology, Drug rash reporting, Department development, Research methodology, Genodermatoses, Investigative dermatology etc.

- Accreditation of CME programmes with different credit points for national (6 pts), zonal, state level CMEs (3 pts) and CMEs conducted by SIGs (3 pts). These credit points can be used as one of the criterion while awarding membership / fellowship certificate from the academy / council. Uniform accreditation certificate will be printed / provided by IADVL on demand from organizers. IADVL president's signature is must. Guidelines for CMEs 1. Under IADVL banner 2. Minimum six hrs programme 3. Maximum five lectures of 45 minutes each with 15 min discussion time. 4. Remaining one hr can be used for brief opening ceremony, post CME evaluation etc. 5. While selecting chair persons due weightage should be given for their academic background and no of yrs put in the specialty. 6. Organizers should send detailed report to IADVL.
- National quiz Co ordinates with National quiz committee, by providing necessary academic inputs like providing resource persons, resource materials etc. and ensuring uniformity of standards throughout the country during various rounds.
- Work with IADVL for Faculty exchange programme / SARAD exchange programmes (rules as announced in IADVL News Letter, VOL 1, issue 2, Dec 2005). Feasibility needs to be assessed as many institutions in India are either autonomous / university administered/govt run or pvt management run.

- Work in-tandem with IADVL to recognize or inspect IADVL training centers for awarding IADVL travel fellowships.
- To help IADVL in awarding Best department (academically) award / Best IADVL academician of the year (individual) / Best PG dissertation of the year.

Guidelines for Best department (academically) award:

- Rolling shield is ideal presentation. Suitable sponsor may be found or IADVL can give the same. The best dept award should speak of intellectual /academic excellence of its faculty as a team.
- 1. No of CMEs / work shop/clinical meetings conducted by the dept. (5 pts per activity)
- 2. No of invited / guest speakers from faculty of dept; national / international.(3 pts per faculty for national & 5 pts for international).
- 3. No of papers published from dept national / international journals. . (1 pt per paper for non indexed, 3 pts per paper for indexed national & 5 pts for indexed international).
- 4. No of papers published in association with other dept, where corresponding author is from other dept (I pt / paper).
- 5. No of paper presented at state (1 pt) / zonal (2pts) / national (3 pts) / international conferences (5 pts). Presenter must be from dept of dermatology. This is applicable to oral presentation. For poster presentation within India, uniformly 1 pt, international 2 pts.
- 6. Oration or guest lecture awarded to faculty members (state level 2 pts/national 5 pts).
- 7. Conducting derma health camps by dept as social obligation (2 pts).





- 8. IADVL Fellowship centre
- 9. STI clinic
- 10. Special Clinics
- 11. HIV medicine services
- 12. Dermatosurgery
- 13. Cosmetology
- 14. Dermatopathology
- 15. Research Projects
- 16. Grants, Awards and Scholarships for dept and staff

Research projects and grants awarded, scholarships awarded should be from reputed agencies like ICMR, WHO, DST etc.

Guidelines for Best IADVL academician of the year (individual):

To encourage non-institutional dermatologists academic activities.

A certificate and plaque may be given. Pharma sponsor can be found (Ref: IADVL News Letter, VOL 1, issue 2, Dec 2005, page 21. Systopic pharma was interested in such activities)

- No of CMEs / work shop conducted by the individual as organizing secretary / chairman (5 pts per activity).
- No of invited lectures / guest speeches delivered by the individual; national / international.(3 pts per for national & 5 pts for international).
- No of papers published as corresponding author (Indexed) national / international journals (3 pts per paper for national & 5 pts for international).
- No of paper presented at state (1 pt) / zonal (2pts) / national (3 pts) / international conferences (5 pts). This is applicable to oral presentation. For poster

presentation within India, uniformly 1 pt, international 2 pts.

5. Oration awarded (state level 2pts / national 5pts).

SPECIAL INTEREST GROUPS (SIGs)

(With reference to Annexure I, (IV) of the Condtitution)

These have to be "set up" by members of the IADVL with the aim of representing and advancing specific specialties in dermatology.

Following is the list of SIGs which can be established. Feasibility, sustainability and availability of adequate man / member power of academic interest have to be assessed before starting them.

Contact Dermatitis / occupational dermatitis group (CDG/ODG)

The aims and functions of the CDG / ODG are to collate and disseminate information on contact dermatitis. It is involved in preventive and environmental issues on behalf of the members and the patients suffering from contact dermatitis

Pigmentary disorder Group (Vitiligo etc)

Disseminate information on all pigmentary disorders with main focus on vitiligo.

Pemphigus Group

Lots of pioneer clinical and therapeutic work has been done by Indian dermatologists. These works need to be continued in this field. Innovative therapeutic modalities developed by this group will give useful guidelines for fellow dermatologists.

Atopic dermatitis Group

In addition to research works, promoting the concept of general management modalities for patients with atopic dermatitis and disseminate these information among public.

Genodermatoses Group

Finding feasibility of setting up a center where diagnostic work-up of patients with genodermatoses is possible with the help of pharmaceutical companies / any other agencies. Starting collaborative projects with overseas centers regarding diagnostic work-up of these patients. Setting-up regional registry systems for various genodermatoses.

Photo dermatology Group (PDG)

Act as a forum of communication for all those with an interest in photo dermatology.. Subjects covered in the PDG should include the photo chemotherapy, UVB phototherapy use of sunscreens and creating public awareness regarding photo protection.

Dermatopathology Group

Aims to promote the knowledge and teaching in dermatopathology for the benefit of members of IADVL and PG students / residents and to stimulate appropriate medical and scientific research relevant to this specialty.

Pediatric Dermatology Group:

Group, to understand the skin diseases in children further and to enhance their care by encouraging education and research in all aspects of pediatric dermatology.

Dermatosurgery / Cosmetic Dermatology Group:

Promote the knowledge and hand-on practice in dematosurgery for members of IADVL and PG students by conducting workshops at various centres. To increase awareness on the scientific basis of using various cosmetic products.

Geriatric Dermatology Group:

Group will attempt to stimulate interest in the skin of the elderly. In particular it is hoped to further understanding of skin diseases in the growing segment of the population and recommend treatments and management systems

HIV / AIDS and STI Group:

To act as an effective liaison between NACO and other agencies.

To formulate and revising guidelines related to HIV and STIs.

Dermatology Clinical / Epidemiological Trials Network (DCETN):

To develop a national network capable of conducting high quality clinical trials. A core expertise body will be selected to apply for external funding from charities and research councils (ICMR etc) in order to fund such trials.

Develop proposals for external funding for clinical trials identified as priorities by the DCETN Group.

Develop an infrastructure for ensuring that such trials are conducted to a high standard of data management and clinical research governance.

To develop educational and training opportunities for those interested in learning about the conduct and interpretation of clinical trials.

Cutaneous Adverse Drug Reaction Study Group (CADRSG):

To establish and maintain regional registry on adverse cutaneous drug reactions and formulating guidelines for management of severe cutaneous drug reactions.

Teledermatology Group:

Dermatology as a morphologically oriented medical specialty is eminently suited to utilize the possibilities of modern technology for the transmission of visual data and images. Teledermatology holds great potential for

Aims to provide a forum for the discussion and development of Teledermatology in India. It should also able to provide a source of professional opinion concerning aspects of teledermatology to other medical and non-medical bodies...

- Offer advice to professionals exploring teledermatology
- Provide educational opportunities for those practicing teledermatology
- Online teaching and learning activities 3.
- Developing online atlas and library

Dermatology Nursing Group:

Dermatology is a highly specialized area of practice. The nurses working in dermatology clinics and wards have limited opportunity to meet with colleagues to discuss patient care, treatments or changes in practice. As nurses provide care for the vast numbers of people who attend skin clinics throughout the country, it has been felt that there is a great need to develop a specialist network of nurses with an interest in dermatology.

- 1. Promote the development and recognition of the nurse's role in dermatology, for the benefit of the patient.
- 2. Promote and support the education of nurses for their role in giving dermatological care.

Functionaries of SIGs:

Each SIG will have one coordinator (who should be a member of the council) and 8 co-opted members, 2 from each zone (at least two of whom should be members of the council). Additional experts from fields other than dermatology may be invited to be part of the meetings (as

invited members) or may be consulted at other times (as consultants) as per the need felt by the group. However, they will not have a fixed tenure and will have to be consulted or invited as per the need felt by the group coordinator.

Coordinator should have done basic work / research in that field. He/she should be an active academician with 10 years' of experience as consultant dermatologist or teacher in a medical college (associate professor and above).

Co-opted members should have done basic work / research in that field. He/she should be an active academician with 5 years' of experience as consultant dermatologist or teacher in a medical college.

Selection of coordinator will be done by a committee consisting of President, IADVL, President elect, IADVL, chairman Academic Council and secretary IADVL.

Selection of co-opted members is done by above committee and coordinator of the particular SIG.

Tenure of the team is three years. Continuity of work is assured with the prescribed term.

Functions of SIGs:

The groups can organize annual training coursespecifically aimed at trainees in dermatology

They can also organize regular updates like symposium, seminar, and workshop on subspecialty.

Newsletters on matters of current importance can be brought

They can promote and carry out or assist in promoting and carrying out research, surveys and investigations and publish the useful results thereof.

Help to update IADVL therapeutic guidelines as resource persons as and when asked by IADVL.

Group Coordinator should send a quarterly report to Coordinator, Academic council. (Who inturn makes a brief of the same to publish in IADVL News letter / IADVL website).
